0:00 Introduction

- 0:23 Born in Prince Edward County Virginia, 1918. Went to College in 1934 and stayed in County until 1955. Moved to Richmond for one year and then to St. Mary's County in 1957. Worked for University of Maryland for 17years. Lives in 8th District in Lexington Park.
- 2:00 Lived on a 125 acre farm in Prince Edward County. Father was a county agriculture agent. Took over job after father retired. They owned and operated a farm. Mother was a housewife.
- 3:30 Earliest memory was looking out of window and watching siblings light firecrackers at Christmas time.
- 4:20 Most of family food came from farm. They raised tobacco, corn and livestock. Father would buy sugar, coffee and fish.

- 5:25 Belong to First Baptist in Farmville.
- 5:40 Only took trips around county. He went to a 4H trip in Hampton when he was nine years old.

- 6:18 Father was involved at church deacon board, NAACP, Beneficial Society.
- 7:00 Times were always the same in and out of depression.

Track 03

- 8:04 Medical offices for white patients and separate office for black patients. Went to a black dentist.
- 10:00 There was a Southside Community Hospital that opened around 1928.
- 10:55 No home remedies.
- 11:45 Senior citizen stayed with younger relatives until they died.

Track 04

11:58 News came from county newspapers. Blacks newspapers and Negro Society. Council of 49. Seven members per county to improve blacks plight in the county.

Track 05

- 17:51 Blacks made up approximately 66% of the counties population right after the civil war. They did well until reconstruction. Around 1930 farmers were not able to get credit
- 20:38 Games: Play jacks, hopscotch, softball, horseshoes, hide and seek.
- 21:13 Chores: Hauled water and wood, feed chickens and hogs, milk cows and cleaned house.
- 21:38 Got along well with brothers and sisters.
- 21:50 Loved to read.
- Parents treated him well. The encourage education and prepared him well for life.

Track 06

Went to Oak Hill Elementary School and Robert R. Morton High School in Prince Edward County. Oak Hill was a two room community school. That serviced about 40 to 50 kids within a few miles. Subjects were reading, English and geography. Secondary school ended at 7th grade.

Before high school was started, the teacher would allow students who graduated from 7th grade to come back and continue education without superintendent's knowledge. There were no public high schools in the county for blacks. There were training schools that did not teach regular curriculum.

- 7:55 Teenagers are same except for their environmental exposure. There were no drugs, TV and internet. Teenagers today don't have chores that take up most of their time.

- 9:53 Race Relations Tremendous improvement with an integrated society.
- 12:57 City vs. County More services available in city.

16:08 Difference between people in different sections of the county.

Northern versus Southern end of the county appeared to teach each others as if they were foreigners. Southerner were generally protestants and northerners were Catholic.

- 20:26 Biggest change in county is the growth in population. A presence of naval base has effected growth and economy of area.
- 24:34 County contribution: Used opportunities for the betterment of county. Was first black chairman of the youth commission. Helped with the development of senior housing.

26:18 Awards – 15 to 20 community services awards.

27:27 Most Valuable thing in lifetime – family and God. Planned to live life day-by-day and to take advantage of whatever resented itself.

30:36 Life in St. Mary's county: County Extension Agent – tobacco farmers were not willing to accept help. Race relations within the Agency and in 4-H.

4-H Club and integrating the Boys Clubs. Suspected that the leaders of the Clubs wanted to resign before allowing Blacks to join. Prejudice within the Clubs.

41:17 Became chairman of housing authority in 1978. Served on school board for a few years. Became a county commissioner after second attempt. Became the swing vote on the board. He was a County Commissioner for two terms.
